1. Introduction

To provide you with our full range of Dealership products and services we need to collect and process certain information about you.

The purpose of this policy is to describe the way that we collect, store, use, and protect information that can be associated with you or another specific natural or juristic person and can be used to identify you or that person (personal information).

This privacy policy must be read in conjunction with our DealershipTerms & Conditions.

The purpose of this policy is to describe the way that we handle your personal information.

2. Audience

This policy applies to you if you are:

- a visitor to our website, mobile site, applications ("apps") or
- a customer who has ordered a product or requested a service that we provide or
- anyone contacting us by phone, SMS, email, in letters and other correspondence, and in person.

This policy applies to you under certain circumstances.

3. Personal information

Personal information includes:

- certain information that we collect automatically when you visit our website;
- certain information collected on submission; and

optional information that you provide to us voluntarily (see below);

but excludes:

- information that has been made anonymous so that it does not identify a specific person:
- permanently de-identified information that does not relate or cannot be traced back to you specifically;
- non-personal statistical information collected and compiled by us; and
- information that you have provided voluntarily inan open, public environment or forum including anyblog, chat room, community, classifieds, or discussion board (because the information has been disclosed in a public forum, it is no longer confidentialand does not constitute personal information subject to protection under this policy).

Personal information includes information we collect (i) automatically when you visit our website,(ii) on submission, and (iii) from you voluntarily.It excludes (i) anonymous, (ii) de-identified, (iii)non-personal statistical, and (iv) public information.

3.1 Common examples

Common examples of the types of personal information which we may collect and process include:

- identifying information— such as your first nameand last name;
- contact information—such as your phone number and email address;

4. Acceptance

4.1 Acceptance required

You acknowledge and accept all the terms of this policy when accessing the website to order a product or request our services.

4.2 Legal capacity

6.Collection

6.1 Purposes for collection

We may use or process any product or services information, or optional information that you provide to usfor the purposes indicated in this privacy policy. Processing includes gathering your personal information, disclosing it, and combining it with other personalinformation. We generally collect and process yourpersonal information for various purposes, including

- **products or services purposes** such as collecting orders or requests for and providing our products or services;
- marketing purposes such as pursuing lawful related marketing activities;
- business purposes such as business intelligence and analytics, product improvement, internal audit, accounting, business planning, and joint ventures, disposals of business, or other proposed and actual transactions; and
- **legal purposes** such as handling claims, complying with regulations, or pursuing good governance.

We may use any of your personal information that you provide to us for the purposes indicated in this privacy policy.

6.2 On product order or service request

When you order a product or request a service fromus, you will be asked to provide us with additional personal information on a voluntary basis (productor services information).

We also provide a service allowing potential buyersto contact the seller about a certain listing. You will need to provide certain personal information such as;

This willenable the dealership or third party tomake contact with you in order to provide you withfurtherinformation related to the vehicle you inquired about.

In certain circumstances, dealers and relevant thirdparties may subsequently transfer, process and storeyour personal information for their business and administration purposes in accordance with their ownprivacy policies. If you have queries or require moreinformation on how dealers or third parties use your personal information, please read their privacy policies or contact them directly.

6.3 Communicating with us

When you communicate with us telephonically, you maybe requested to provide personal information tous such as your name, email address and contact details. We will use this in order to help resolve yourquery or complaint.

We collect certain information when you order a productor request our services from us.

6.4 Messages and updates

We may send administrative messages and email updatesto you about the website. We may wish to provide you with information about new products or services in which we think you may be interested. This means that in some cases, we may also send you primarily promotional messages. We may send you one message to ask you for your opt-in to receive promotional messages. We will not send you promotional messages unless you have chosen to opt-intothem.

We may use your information to send you administrative messages and email updates to you regarding the website and for marketing purposes where lawful.

6.5 From browser

We automatically receive and record Internet usage information on our server logs from your browser, such as your Internet Protocol address (IP address),browsing activities, click patterns, version of software installed, system type, screen resolutions, colour capabilities, plug-ins, language settings, cookie preferences, search engine keywords, Java Script enablement, the content and pages that you access onthe website, and the dates and times that you visit the website, paths taken, and time spent on sites and pages within the website (usage information). Please note that other websites visited before entering our website might place personal information withinyour URL during a visit to it, and we have no controlover such websites.

We collect certain information from your web browser, including your Internet usage informationwhen you visit our website.

6.6 Cookies

We may place small text files called 'cookies' on your device when you visit our website. Cookies are used to enhance your experience on websites by remembering your preferences etc. For more information please refer to our cookie policy.

We collect certain information from cookies that wemay send to your computer to try and give you a personalised experience.

6.7 Optional details

You may also provide additional information to uson a voluntary basis (optional information). This includes content or products that you decide to upload or download from our website or when you enter competitions, take advantage of promotions, respond to surveys, order additional products or services, or otherwise use the optional features and functionality of our website.

We collect certain optional information that you provide when you upload or download content from our website or when you enter compititions, take advantage of promotions, respond to surveys or register and subscribe for certain additional products or services.

6.8 Recording calls

We may monitor and record any telephone calls that you make to us, unless you specifically request usnot to.

We may use any of your personal information that you provide to us for the purposes indicated in this privacy policy.

6.9 Consent to collection

We will request your explicit consent to use your personal information to send you certain information including:

Newsletters

Where you have given consent to process your personal information you may withdraw consent at anytime by clicking the unsubscribe link in an email alert or newsletter.

In certain cases we will get your consent to use yourpersonal information and you may withdrawyour consent at any time.

7. Disclosure

7.1 Sharing

We may share your personal information with:

- other divisions or companies within the group of companies to which we belong so as to provide joint content and services like registration, for transactions and customer support, to help detect and prevent potentially illegal acts and violations of our policies, and to guide decisions about our products, services, and communications (they will only use this information to send you marketing communications if you have requested their products or services):
- an affiliate, in which case we will seek to require the affiliates to honour this privacy policy;
- our products or services providers under contract who help provide certain
 products or services or help with parts of our business operations, including
 fraud prevention, bill collection, payment services, credit checks, marketing,
 technology services (our contracts dictate that these product or services
 providers only use your information in connectionwith the products or services
 they supply or services they perform for us and not for their own benefit);

We may share your personal information with third parties for the purposes of fulfilling our obligations to you among other purposes.

7.2 Regulators

We may disclose your personal information as required by law or governmental audit. This will include public authorities, insurance companies, finance companies, automotive advertising companies and/orother agencies. Information shared in this way will not be used for marketing purpose

7.3 Law enforcement

For the purposes of the prevention or detection ofoffences, and/or the apprehension or prosecution of offenders, we may share any information obtained or collected by us with the Police, other public orprivate sector agencies or representative bodies inaccordance with the relevant legislation.

We may disclose personal information if required:

by a subpoena or court order;

- to comply with any law;
- to protect the safety of any individual or the generalpublic; and
- to prevent violation of our customer relationship terms.

We may disclose personal information to third parties if required for legal reasons.

7.4 Marketing purposes

We may disclose aggregate statistics (informationabout the customer population in general terms) about he personal information to advertisers or business partners.

7.5 Employees

We may need to disclose personal information to our employees that require the personal information to do their jobs. These include our responsible management, human resources, accounting, audit, compliance, information technology, or other personnel.

7.6 Change of ownership

If we undergo a change in ownership, or a merger with, acquisition by, or sale of assets to another entity, we may assign our rights to the personal informationwe process to a successor, purchaser, or separateentity. We will disclose the transfer on the website. If you are concerned about your personal information migrating to a new owner, you may request us to delete your personal information.

8. Security

All the information we receive about you is stored on secure servers and we have implemented technical and organisational measures that are suitable and necessary to protect your personal data. We continually evaluates the security of our network and adequacy of our internal information security program which is designed to (a) help secure your data against accidental or unlawful loss, access ordisclosure, (b) identify reasonably foreseeable risks to the security of our network, and (c) minimize security risks, including through risk assessment and regular testing.

Please note, despite the measures we have implemented to protect your data, the transfer of data through the Internet or other open networks is never completely secure and there is a risk that your personal data may be accessed by unauthorised third parties.

We will take all reasonable steps to ensure that your data is treated securely and in accordance with this policy

9. Accurate and up to date

We will try to keep the personal information we collect as accurate, complete and up to date as isnecessary for the purposes defined in this policy. You are able to review or update any personal information that we hold on you by emailing us, or phoning us. Please note that in order to better protect you and safeguard your personal information, we take steps to verify your identity before making any corrections to your personal information.

Please keep your personal information accurate andup to date by accessing your account online, emailing us, by phoning us.

10. Retention

We will only retain your personal information foras long as it is necessary to fulfil the purposes explicitly set out in this policy, unless:

- · retention of the record is required or authorisedby law; or
- you have consented to the retention of the record.

During the period of retention, we will continue to abide by our non-disclosure obligations and willnotshare or sell your personal information.

We may retain your personal information in physical or electronic records at our discretion.

We will only retain your personal information for as long as is necessary.

11. Transfer to another country

We will not transfer any personal information a cross a country border without your prior written consent.

We may not transfer your personal information outside the country in which it was collected to a foreign country without your permission.

12. Removing

You may choose to remove the personal informationyou have submitted to us, by contacting us.

We will request proof of identity before removing your information.

You may choose to update or remove the personal information you have submitted to us.

13. Limitation

We are not responsible for, give no warranties, nor make any representations in respect of the privacy policies or practices of linked or any third party websites.
